- Fixing: Surface mounted. Intended to be used while fastened to a support.
- Dimming: Non Dimmable.








CCT SELECT OR SWITCH



WATTAGE SELECT OR SWITCH

Installation Instructions:

1. Ensure mains supply is switched OFF.
2. Unscrew and slide end cap off (Figure 1). Do not attempt to remove end cap which is secured with one way security screws.
3. Slide diffuser off.
4. Use fitting as a template to drill mounting and cable entry holes (Figure 2).
5. Mount the fitting using screws provided (and Rawl plugs if necessary).
6. Connect mains wiring to terminal block (Figure 3).
7. Refit diffuser and end cap.
8. Secure end cap with screw.
9. Select desired colour temperature via end cap switch.
10. Turn the power on.

Changing CCT or Wattage: (Figure 4)

For CCT slide CCT SELECTOR SWITCH to desired colour temperature – WW (3000K) CW(4200K) DL(6500K)

For WATTAGE select between 10W/20W (21795/05) or 20W/40W (21796/05)
