


FINN 18675 & 18677 Metal Pendants


Before using your new FINN Pendants it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document handy for future reference.

THIS FITTING MUST BE INSTALLED BY A QUALIFIED ELECTRICAL CONTRACTOR



Installation Instructions

- 1) Ensure the power is switched off at the mains.
- 2) Unpack the product carefully and place it on a flat surface.
- Use screws 'B' and suitable fixture system to secure the mounting bar 'A' to the ceiling. Rawl plugs need to be used for concrete ceilings.
- 4) Connect the Live (L), Neutral (N) and Earth (E) according to the markings on the Terminal Block 'C' :



- Adjust the suspension cord length required and slide canopy 'D' up on the cord by pushing it up against the ceiling. Ensure the cord anchorage screw 'I is tighten firmly.
- 6) Attach canopy 'D' onto mounting bar 'A' with decorative screws 'F'. Tighten the screws firmly.
- 7) Install correct E27 globe into the lampholder (not included).
- 8) Reconnect power at main switch.
- 9) Switch on the pendant.

Proof of installation by qualified personnel may be required, eg. Electrical Safety Certificate. Proof of purchase must be supplied with all warranty claims.

This warranty is provided in addition to any other rights and remedies of the customer under any law. In applications not intended for household, personal or domestic use, liability is limited to replacement or reimbursement of product only. Brilliant Lighting does not warranty the costs of removal or re-installation of this product or associated components.

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if goods fail to be of acceptable quality and the failure does not amount to a major failure.

Any claim under this warranty must be made within 1 year of the date of purchase of the product.
