





Before first using your new Downlight, it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document for future reference.

## FITTING MUST BE INSTALLED BY A QUALIFIED ELECTRICAL CONTRACTOR

Note\* - Product image may vary for illustration purposes only and may/may not depict actual product.



### Warning:

- Installation, repair and/or inspection must be conducted by qualified personnel in accordance with Australian Standards and local Building codes.
- Care must be taken to ensure electrical wiring and other hidden utilities are not damaged when ceiling is cut.
- Do not install in a position where the unit will be accessible to children or infirm persons.
- Do not perform modification to the unit.
- If the supply cord is damaged it should be replaced by the manufacturer or qualified person to avoid a hazard.
- Failure to follow these instructions may void the warranty.

### Installation:

- Disconnect power.
- Cut a hole in ceiling Ø82mm.
- Insert plug and cord into the ceiling and connect the 2-Pin mains plug to a suitable power socket.
- Lift the spring clips up and insert light into ceiling.
- Refer page 2 "INSULATION RATING IC-4" for building element and insulation clearance requirements.
- Restore power.

## Installation of Interchangeable Ring.

Note\* removal of downlight from recess may need to be applied for fitment of interchangeable ring.

### Remove:

1. Turn off light at wall switch.
2. Grip Interchangeable ring and twist Anti-Clockwise
3. Remove Interchangeable ring from downlight rim




### Replace:

1. Line up Locking guides on Downlight with slots on selected Interchangeable ring
2. Grip ring and twist Clockwise locking in place on downlight rim – must be secured firmly
3. Turn on light at wall switch

## INSULATION RATING IC-F IC-4:


This Downlight has achieved an IC-F IC-4 insulation rating in accordance with AS/NZS 60598.2.2.
